
## The VISS promise during the Online Learning period

VISS will continue to offer a range of student engagement and wellbeing initiatives for all students

## Ministry of Education directive regarding participation in the Online Learning program and progression to the next academic year



It is very important that our families are aware of the specific directive from the MOE that pertain to completing this academic year.

## Below are 2 Directives from the MOE circular

- "All Students MUST continue their registration and enrollment during the Period of Application of Distance Learning). In the event of non-compliance, the student is considered Withdrawn from the Academic Year"
- "Unless a decision is issued otherwise, Distance Learning is treated as equivalent to the Normal Learning (achieved by attending at the premises of the Educational Institution) in all Laws, Decrees, and Regulations, but only during the Application Period"
- Whilst this directive is positive in that it clearly allows for the smooth transition between this academic year and next year, it does require full participation and engagement from students for the whole term

We value your support in ensuring students are ready and prepared for school each day and they are keeping up with their work. Our teachers will monitor students' progress very closely and our wellbeing teams will be monitoring attendance and engagement daily.

Furthermore, we expect all of our students to maintain very high standards of behavior in online classes. The school will follow up on unacceptable online behavior and hold student accountable for their conduct, as we would do in the normal classroom environment.
